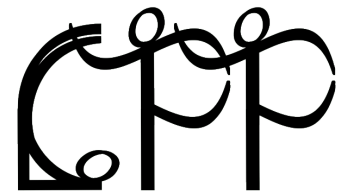

### **1. AGREEMENT TO TERMS**

#### **Definitions**

When the following words with capital letters are used in these Terms, this is what they will mean:

1/ Services: the treatment or course of treatments that We will provide to You;

2/ Terms: the terms and conditions set out in this document;

3/ We/Our/Us: Cheshire Physiotherapy and Pilates Clinic; Company number: 13835907  
Middlewood Road, Poynton, Cheshire, Sk12 1SH; and

4/ You/Your: the person who We provide the Services to.

When We use the words “writing” or “written” in these Terms, this will include e-mail unless We say otherwise.

When You book an appointment for the Services, this will be treated as an offer to purchase those Services.

The contract between You and Us will only be completed and become binding on You and Us when We confirm to You that We can provide the Services as requested, We provide such Services to You or when We take any payment from You (which includes debiting Your chosen payment method), whichever is the earlier.

#### **Price And Payment**

The price of the Services will be set out in Our price list in force at the time We confirm your Order. Our prices may change at any time, but price changes will not affect Orders that We have confirmed with you. Payments can be made using Debit or Credit Card/ BACS or Cash payments.

#### **Private Medical Insurance**

If your treatments are being covered by private health insurance there are a couple of things to know.

You will need to obtain authorisation from your private health insurer and provide us with these details before your treatment at Cheshire Physiotherapy and Pilates Clinic LTD can commence.

We will require your authorisation code and membership number before or on your first appointment.

We may ask you to provide card details which will be stored securely as per current GDPR requirements. This is in line with our cancellation and insurance policies (see below).

#### **Your Rights to Cancel Or Reschedule Your Appointment**

Unless otherwise specified in your booking confirmation, the rules below on cancellation and applicable charges shall apply to Your Booking.

Subject to the following terms, you have the right to cancel or reschedule Your Appointment and You can do so by contacting Us on 01625 250403 or 07496894679 in advance of Your Appointment during the working hours provided on the Cheshire Physiotherapy and Pilates Clinic website, excluding bank and other public holidays.

You must provide a minimum of 24 hours prior notice to cancel or change an Appointment by contacting Cheshire Physiotherapy and Pilates Clinic as set out above. If You cancel an Appointment or change your appointment with less than 24 hours' notice or if You fail to attend your Appointment for any reason, You may incur a cancellation charge of or a Did Not Attend charge where you will be charged the full amount for your selected appointment on that day. All patient attending Cheshire Physiotherapy and Pilates Clinic through their private health insurer may be asked to provide card details in line with our cancellation policy and in circumstances where your private health insurer may not cover your treatment.

If we cancel your appointment by providing sufficient minimum notice and You have made any payment in advance, We will refund these amounts to You.

### **Our Rights To Cancel And Applicable Refund**

We may have to cancel Your Appointment due to an event outside our control or the unavailability of the relevant Cheshire Physiotherapy and Pilates Clinic LTD professional. We will promptly contact you if this happens.

If we have to cancel an Appointment and you have made any payment in advance, We will refund these amounts to You.

Where You have booked a course of Appointments, and We have to cancel subsequent Your Appointments, We will refund payments on a pro-rata basis for those Appointments which have been cancelled.

You agree that by accessing the Site, you have read, understood, and agreed to be bound by all of these Terms of Use. **IF YOU DO NOT AGREE WITH ALL OF THESE TERMS OF USE, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE SITE AND YOU MUST DISCONTINUE USE IMMEDIATELY.**

If your habitual residence is in the EU, and you are a consumer, you additionally possess the protection provided to you by obligatory provisions of the law of your country of residence Cheshire Physiotherapy and Pilates Clinic and yourself both agree to submit to the non-exclusive jurisdiction of the courts of Manchester, which means that you may make a claim to defend your consumer protection rights in regards to these Terms of Use in England, or in the EU country in which you reside.

## **14. DISPUTE RESOLUTION**

### **Informal Negotiations**

To expedite resolution and control the cost of any dispute, controversy, or claim related to these Terms of Use (each "Dispute" and collectively, the "Disputes") brought by either you or us (individually, a "Party" and collectively, the "Parties"), the Parties agree to first attempt to negotiate any Dispute (except those Disputes expressly provided below) informally for at least thirty (30) days before initiating arbitration. Such informal negotiations commence upon written notice from one Party to the other Party.

### **Binding Arbitration**

Any dispute arising from the relationships between the Parties to this contract shall be determined by one arbitrator who will be chosen in accordance with the Arbitration and Internal Rules of the European Court of Arbitration being part of the European Centre of Arbitration having its seat in Strasbourg, and which are in force at the time the application for arbitration is filed, and of which adoption of this clause constitutes acceptance. The seat of arbitration shall be Manchester, England. The language of the proceedings shall be English. Applicable rules of substantive law shall be the law of England.

### **Restrictions**

The Parties agree that any arbitration shall be limited to the Dispute between the Parties individually. To the full extent permitted by law, (a) no arbitration shall be joined with any other proceeding; (b) there is no right or authority for any Dispute to be arbitrated on a class-action basis or to utilize class action procedures; and (c) there is no right or authority for any Dispute to be brought in a purported representative capacity on behalf of the general public or any other persons.

### **Exceptions to Informal Negotiations and Arbitration**

The Parties agree that the following Disputes are not subject to the above provisions concerning informal negotiations and binding arbitration: (a) any Disputes seeking to enforce or protect, or concerning the validity of, any of the intellectual property rights of a Party; (b) any Dispute related to, or arising from, allegations of theft, piracy, invasion of privacy, or unauthorized use; and (c) any claim for injunctive relief. If this provision is found to be illegal or unenforceable, then neither Party will elect to arbitrate any Dispute falling within that portion of this provision found to be illegal or unenforceable and such Dispute shall be decided by a court of competent jurisdiction within the courts listed for jurisdiction above, and the Parties agree to submit to the personal jurisdiction of that court.

## **15. CORRECTIONS**
